On behalf of INL W, I have written to Helena Benitez to congratulate her on this programme to recognise women's achievements.

### **4. CEDAW (Convention on the Elimination of All Forms of Discrimination against Women)**

Nations which have signed up to this Convention are required to submit a report to United Nations every four years, regarding their progress in eliminating discrimination. These reports are realistic only if they are based on consultation with women's organisations. This year (1998) the UK Government has for the first time formally consulted its official, independent women's advisory body, The Women's National Commission.

We are very pleased about this and would like to publicise evidence of other Government's consultation with women's groups. Please send your news to me, for inc1usion in the next INLW news letter.

### **5. Bella Abzug** will be remembered by INLW members who attended the CSW meeting in March this year. She was the lady in a hat, in a wheelchair, who received great applause for her rousing speech in a plenary session. Bella died a fortnight later. She founded WEDO (Women's Environment and Development Association) and argued in the US House of Representatives as early as 1971 for federally financed 24 hour childcare. I sent condolences to WEDO on behalf of INL W and inquired about an association with them, as they are a most valuable source of information.

## 6. **Re-orientation of EU Funds**

The European Commission has announced a radical re-orientation of Structural Funds after 1999, to concentrate on three objectives:

*Helping the poorer European regions, helping areas facing decline in employment opportunities and modernising education, training and employment policies. This third objective will promote social inclusion and improvements in women's participation in the labour market.*

Padraig Flynn, Commissioner responsible for Employment and Social Affairs, stated ..."I am determined... that equal opportunities for women and men should be addressed right across the Structural Funds programmes and initiatives..." "The focus has shifted from women as a group with additional needs to the more complex patterns of relations between the genders". For example, he points out, "the unequal share of domestic work and family care disadvantages women in the labour market (and) advantages men". He is promoting conciliation of work and personal life, support for child care and care of dependant's and improved organisation of working time.

These issues are all well known to INLW members but it is welcome to see them highlighted in European policies.
