INLW CASABLANCA MEETING MARCH 2003

was to meet Moroccan women at a scheduled time, but the Secretary General's flight was late and unfortunately although everything was arranged by L.I. this meeting did not take place.

L.I. awarded the Freedom Prize to Maître Abdoulaye Wade, president of the Republic of Senegal, on which occasion he pronounced a memorable speech on Islam and Occident.

INLW Secretary General J.Alemany reported to the Executive Meeting the set-up of INLW website and electronic mail and the recommendation to be granted Special consultative status from ECOSOC U.N. She also took part in the deliberation of the Iraqi Urgency Resolution.

INLW DAKAR GENERAL MEETING 23 OCTOBER 2003

The meeting was scheduled within the 52 Congress of L.I. and took place in the amphitheatre of the Méridien President Hotel where we felt comfortable for our deliberation and where we chose our new Management Board.

U.N. DPI/NGO's 56th Conference on" Human Security and Dignity, fulfilling the promise of the United Nations" held in New York September 2003, was attended by Joaquima Alemany, Secretary General INLW and M. Carmen Solsona member INLW. The message to the 56th annual DPI/NGO Conference by Secretary General of U.N. Mr. KOFI ANNAN, stressed that universal human securities is at the heart of the Millennium Development Goals, embraced by all Member States as a blueprint for building a better world in the twenty-first century.

The traditional concept of security, viewed in national and military terms, are tied more to relations between States than among people. However, true human security, as defined by a report of the Commission on Human Security, is the aspiration of people seeking well-being and dignity in their daily lives, which means simply meeting basic human needs and ensuring vital freedom.

The plenary sessions focussed on five points:

- Psychological synergies ensuring security and human dignity
- Education as a pillar for the future
- Empowerment of groups to overcome oppression
- Sustainable solutions for the environment
- Best practices, effective partnerships, challenges and possible roles of international community and civil society in this vital process.

To notice the important role of women in this processes; they transmit culture and are benefiting education and are promoters of peace-making.

On the other hand Jeannine de Boccard as representative of international relations, assisted to the substantive session of ECOSOC at Geneva in July 2003 on the issue "Promoting an integrated approach to rural development in developing countries for poverty eradication and sustainable development".

After a twenty years hiatus, farming and rural life are regaining global attention. For too long a period the basic conditions of rural live and the agriculture has been put aside to the benefit of urban policies and rural areas did continue to decline towards absolute poverty and women were specially hit by those bad conditions of life. Moreover natural disasters, low wages offered by big companies also have aggravated the situation. Given that the majority of the world's poor, among them women being the poorest, live and work in rural areas, government policies should focus on the improvement of the quality of services, economic as well as social, in order to implement the millennium goal of reducing poverty. A certain number of resolutions were adopted during the session towards the promotion of decent rural jobs, waged agricultural employment, safety, access to training and women's access to land and credit.

On 10 -12 December 2003 Mme de Boccard also assisted to the **Preparatory Session for the Summit on the Information Society held at Geneva**.

The idea to hold a Summit related to the emerging information society was first raised during the Plenipotentiary Conference of the International Communication Union IUT and later was endorsed by the UN General Assembly Resolution 56/83.

The International Union of Telecommunication IUT is in charge to put up this Summit in Tunis in 2005.

The guiding principles are:

- Ensure goals of UN as to considering human ethical and social dimension.
- Communication as human rights includes freedom of expression, information and right
 of privacy.
- Improvement of economic models implies discussion on key issues such as intellectual property.

- Governance, as one of the thematic areas includes the enhancement of democratic progress at all levels.
- Community controlled information infrastructure should be a priority.
- Variety of new and traditional information and communication technologies and media should be included in all discussions.
- Social appropriation of ICT issues trough broad based education and knowledge exchange.

Women NGO's insisted on the terms of equality between men and women and a specific approach to different social groups, marginalized and discriminated such as women, youth, older and indigenous people.
